Target CEO Attempts Damage Control After Weeks of Silence and Mounting Backlash

Target CEO Brian Cornell acknowledged in an email to employees this week that a months-long lapse in communication has

created uncertainty. The retailer is grappling with falling foot traffic, public boycotts, and criticism over its retreat from diversity

'Love Must Be Louder Than Hate': NAACP Raises Over \$340K for Black Child Targeted in Racist Verbal Attack



Outrage has turned to action in Rochester after a white woman launched a racist verbal assault on a 5year-old Black child at a public park—an incident that has sparked national condemnation, a surge of community support, and a flood of donations aimed at helping the young victim heal. The Rochester Branch of the NAACP said the incident, which occurred on April 30, was a deliberate and threatening act of racial hate—not a misunderstanding or isolated outburst. According to the organization, the child, who is also reportedly on the autism spectrum, was targeted with repeated racial slurs, including the n-word. The woman did not express remorse and doubled down when confronted by a bystander. "This was not simply offensive behavior—it was an intentional racist, threatening, hateful, and verbal attack against a child, and it must be treated as such," the Rochester Branch of the NAACP said in a statement. "Public parks should be safe, inclusive spaces for children and families—not sites of hate

and trauma." A widely circulated video of the incident drew sharp backlash, as did the woman's subsequent move to launch a fundraising campaign for herself. She identified herself as Shiloh Hendrix and claimed she needed financial help to relocate in the aftermath. In less than 24 hours, her campaign raised nearly \$150,000. As of this week, it has surpassed \$600,000, with many of her supporters openly defending her use of racial slurs and demonizing the child. In response, the Rochester Branch of the NAACP acted quickly, launching a GoFundMe campaign to support the young victim and his family. That campaign has since raised \$341,484 in just two days,

Don't have a REAL ID yet? That could cause you travel headaches after May 7

NEW YORK (AP) — will also need one to access The deadline to get a REAL ID is almost here, after nearly two decades of postponements and delays.

While it was initially said that you would not be able to fly domestically without a REAL ID or other TSAapproved form of identification once the May 7 deadline hits, the head of Homeland Security said Tuesday that travelers will still be able to fly, but should be prepared for additional steps at TSA.

If you still don't have your REAL ID and are confused about how to get one, or are wondering why you even need one in the first place, here are some things to know:

What is a REAL ID?

It's a federally compliant state-issued license or identification card that the DHS says is a more secure form of identification. That's because getting a REAL ID remore personal quires documentation than what's required to obtain a regular license.

Besides needing a REAL ID to fly domestically, you certain federal buildings and

When the REAL ID Act was signed into law in 2005, it enacted a recommendation from the 9/11 Commission that the government set security standards for stateissued driver's licenses and

"REAL ID is a coordinated effort by the federal government to improve the reliability and accuracy of driver's licenses and identification cards," John Essig, the Transportation Security Administration's Security Director for airports in the New York City region said in a press release on April 3. "The improvements are intended to inhibit terrorists' ability to evade detection by using fraudulent identification."

The REAL ID Act was supposed to begin rolling out in 2008, "but has faced repeated delays due to state implementation challenges and the COVID-19 pandemic," said Nina Ruggiero,

The May 1 edition of Let It Be Known began with a pair of videos featuring journalist Charles Blow and U.S. Rep. Jasmine Crockett, who delivered searing critiques of a House Judiciary Committee vote that, as Crockett described it, gives former President Donald Trump the power to deport U.S. citizens. Crockett, visibly outraged, revealed the shocking development during a live markup session, warning that constitutional protections are being

gutted in real time. "They just voted to give Trump the legal ability to deport U.S. citizens," Crockett said. "They did it during the same week we learned a fouryear-old American child with cancer was deported, separated from her father, and cut off from her treatment." Crockett, joined by fellow Rep. Deborah Ross and others, said Republican lawmakers refused to support an amendment she

tough few months." It said media coverage, social media chatter, and internal conversations "may have left you wondering." He insisted, however, that Target's values have not shifted. "I recognize that silence from us has created uncertainty, so I want to be very clear: We are still the Target you know and believe in," Cornell wrote. Since the beginning of the year, the retail giant has faced a storm of challenges. President Donald Trump's tariffs on global imports have squeezed the company's margins. Target's decision to scale back its diversity, equity, and inclu-(DEI) initiatives prompted widespread backlash from Black leaders and organizations. "Black consumers helped build Target into a retail giant, and now they are making their voices heard," said Dr. Benjamin F. Chavis Jr., pres-

ident and CEO of the

National Newspaper Publishers Association (NNPA). The NNPA is a trade association representing the 198-year-old Black Press of America. Earlier this year, the Black Press began a public education and selective buying campaign in response to Target abandoning its commitment to Black America. "If corporations believe they can roll back diversity commitments without sequence, they mistaken," Chavis stated.

The company has yet to to respond repeated requests for meetings and comment from The Black Press. Target has lost more than \$15 billion in revenue this year, seen its stock price fall by as much as \$27.27 per share, and is facing multiple lawsuits tied to its DEI policy changes. Cornell's email still struck a tone of reassurance, calling the company's values of "inclusivity, connection, drive" non-negotiable.

ing more of that impact with you and our guests because it reinforces our values and shows the real heart of our team," he wrote. Still, retail analysts were sharply critical. Neil Saunders, managing director at GlobalData Retail, said the email fails to address the root causes of public concern. "They say, 'Our products and experience are second to none.' Well, actually, no, they're not. That's not true anymore," he said. According to data from Placer.ai, foot traffic to Target stores has dropped for 11 straight weeks, with only a slight uptick during the week of April 14 and April 21. Overall, foot traffic declined 3.3% in April. In recent weeks, Cornell

met with Rev. Al Sharpton and leaders of the boycott movement to discuss Target's DEI pullback. He also met with Trump to outline the damaging impact of tarmeeting was believed to have been mentioned in his message to employees. Rev. Jamal Bryant, launched a national Target Fast to protest the company's direction, has called for continued mobilization and accountability. Retail consultant Carol Spieckerman said the CEO's email failed to take responsibility. "His email acknowledges but doesn't take responsibility for any of the concerns and controversies surrounding the company," she said. "The tone implies that things are happening around and to Target that are out of its control." Both Spieckerman and Saunders described the message as unfocused. "It's a really jumbled email," Saunders said. "And you know if it's come from Brian Cornell, it's probably been through about 30 different people and various PR teams, and it still comes out as this big, jumbled mess."

Student Loan Repayment Notices Start May 5

Millions of student loan borrowers in default will begin to get notices starting May 5, that they are being placed into a collections process. The student loan repayment system has always been confusing to many. Delays related to COVID and other policies passed by the Biden Administration were meant to as-

sist borrowers. But now the grace period for student loan borrowers is over after a five-year pause in collections. From 2021 to 2024, federal student loan debt grew by more than \$60 billion annually. According to NBC, only a third of "the nearly 43 million borrowers who have student loan debt have made regular pay-

ments." On April 21, the Secretary of the U.S. Department of Education, Linda McMahon, announced in a statement that the Trump Administration would restart the payments.

In late February of this year, the Department of Education ended the process for loan repayment plans. The U.S. Court of

Appeals for the Eighth Circuit agreed with a suspension of the Saving on a Valuable Education plan—also known as SAVE. The income-driven repayment program, which was a key initiative of the Biden Administration with over eight million borrowers enrolled,

Living by Biblical Faith

Hebrews 11:20-22

In retrospect, we were introduced to the tremendous wonderment of faith exhibited in the life of Abraham (Hebrews 11:8-19). Abraham was an outstanding example of one who demonstrated unusual faith in God's promise to grant him a son when he and Sarah were past age. Abraham's supreme test of faith came when God told him to offer up his promised son Isaac upon the altar!

With unhesitating obedience, Abraham set forth to offer to God the dearest treasure of his heart! Although the promise of a great progeny was to be fulfilled through Isaac, the promised seed; however, Abraham believed firmly that if God required him to slay his son, God would raise him from the dead in

How do I know if I already have a REAL ID?

If you've gotten a new ID in the last few years, it could already be REAL ID-compliant.

"I also hear from travelers who are confused as to whether or not they already have a REAL ID," Ruggiero said. "Some people who have recently renewed their license may already have a compliant ID and not know it," so you may want to doublecheck yours before starting the process.

A REAL ID-compliant driver's license has a symbol (in most states, a star) in the top corner of the

If you live in Michigan, Minnesota, New York, Vermont or Washington, it's possible you could have an "enhanced" ID card instead, which permits you to both fly domestically and cross land and sea borders into Mexico and Canada from the U.S. It does not, however, allow you to fly into either of those countries.

Enhanced IDs will have an American flag icon, as well as the word "enhanced" at the top of the





Houston sent to early playoff exit with 103-89 loss to Warriors in Game 7

HOUSTON (AP) — With a chance to close out their first-round playoff series against the Golden State Warriors, the Houston Rockets instead delivered a playoff flop to end their season Sunday night.

The Rockets won consecutive games to claw back from a 3-1 deficit and force a Game 7 but played their worst game of the series to be sent packing with a 103-89 loss.

"We had our chances in this series," coach Ime Udoka said. "We all expected to continue to be playing so it's a letdown. It's going to sting now but use it as motivation and let's all come back better. Don't be satisfied."

Houston won 52 games to capture the No. 2 seed in the Western Conference and return to the postseason for the first time since

2020. The seven seed Warriors eliminated the Rockets in the playoffs for a fifth time after doing so four times between 2015 and 2019.

"We had whatever amount of wins and second place and all that, but nobody cares about that right now," Udoka said. "It's about where we finished."

Stephen Curry scored 14 of his 22 points in the fourth quarter and Buddy Hield made nine 3-pointers and finished with 33 points to lead Golden State to the win.

Hield was 9 of 11 from 3-point range, setting an NBA record for a Game 7 and making more 3s than the Rockets, who were 6 of 18 from long range.

They didn't lead after the first quarter and allowed Curry to get going in the second half to put the game away after Hield carried the team in first two quarters.

Fred Vleet scored a combined 55 points in the last two games to help Houston extend the series. But he was limited to 17 points on 6-of-13 shooting Sunday as the Rockets were sent home early.

He was far from the only Rockets player who struggled. Big man Alperen Sengun had 21 points and 14 rebounds. But he missed several easy shots on a 9-of-23 night.

Despite the loss, Sengun was proud to see the growth of the team which won just 22 games in the 2022-23 season.

"We learned how to play together," he said. "We talk every day. It was a hard series for us. Obviously, we're upset right now, but it's going to be a great offseason for us and it's going

Jalen Green, who had 38 points to lead Houston to a Game 2 win, finished with eight points.

"First playoffs is no excuse," he said. "I've got to be better."

Green, who was the second overall pick in the 2021 draft, was criticized during this series for not doing more to lead the team after scoring fewer than 10 points in four of the seven games.

But VanVleet took up for his teammate.

"Everybody's journey is different," he said. "The weight of the world seems to be on his shoulders at times, but he played well. We knew they were going to load up on him. On the path to greatness, there's going to be stumbles and failures."

offered lower monthly payments than previous plans. However, the SAVE plan faced legal challenges in the spring of 2024 because of high costs. States led by Republican Governors and Attorney Generals sued and argued that the administration had exceeded its legal authority. The argument of the executive branch "exceeding authority" hasn't come up from those same Republican-led states. But President Trump is moving facts to mandate that those who have a student loan outstanding must repay it.

According to the information provided by the Student Borrower Protection Center:

• A typical current student loan borrower with a college degree will be forced to pay an additional \$2,928 per year in student loan payments should Congress enact this proposal, when compared to the Saving on a Valuable Education (SAVE) plan.

• A typical current student loan borrower with some college but no degree would be forced to repay an additional \$1,761 per year in student loan payments should Congress enact this proposal, when compared to the SAVE plan.

Virginia Rep. Bobby Scott, who is the ranking member of the House Edu-

been a vocal advocate for student loan borrowers. He introduced legislation aimed at lowering the cost of college and assisting with loan repayment. His legislation has included the Lowering Obstacles to Achievement (LOAN) Act, which aims to double the Pell Grant, improve Public Service Loan Forgiveness, lower interest rates, make loans less expensive, and repeal origination fees. Rep. Scott also supported proposals to expand access to Pell Grants, make student loans more affordable, and improve the Public Service Loan Forgiveness program. But in a survival of the fittest world in part created by citizens united, having access to large amounts of money is typically a huge factor in attending college. "Forgiving student debt would be a great gift to graduates, but so would having your mortgages, car loans, and credit card debt forgiven. Debt forgiveness is a slap in the face to all who sacrificed and worked extra jobs to pay off their student loans," argued businessman and media owner Armstrong Williams on social media on May 5. But the question of whether those in default can repay at an unpredictable economic time is unknown.

introduced only because, she said, "ICE is doing it anyway." "I entered into the record that ICE cannot legally detain or deport U.S. citizens, and they still voted no," said Crockett. "Some didn't even show up to vote—too cowardly to go on record."

The broadcast picked up with Let It Be Known hosts Stacy Brown and Niele Anderson expressing disbelief over the vote and noting the racial dynamics at play. "There's a reason they don't care," Anderson said. "It's because they know who will be targeted-Black and brown people, people with accents, those with darker skin." Brown and Anderson drew attention to the House's refusal to provide due process protection, de-

scribing it as dangerous unconstitutional. Brown compared the current moment to the cruelty of America's past. "It used to be that the U.S. brought in children from other countries for cancer treatment," he said. "Now, they're sending American children away—sick, fouryear-old cancer patients." The hosts also discussed the global rise of far-right authoritarianism, highlighting recent events in Burkina Faso, where U.S. involvement is being blamed for fomenting unrest. Anderson noted the parallels with Project 2025 in the U.S., saying the movement isn't just national but global in scope.

Vice President Kamala Harris's first major speech since leaving the White House also came up. Harris warned that Trump is "a extremist agenda. "Fear isn't the only thing that's contagious," Harris said. "Courage is contagious, too." Anderson credited Emerge CEO A'shanti Gholar for the platform that helped amplify Harris's voice. "Emerge has been training women to lead, and it matters that a Black woman leads that organization," she said. The show touched on youth cell phone bans in schools, eliciting passionate opinions on both sides. Some viewers supported the bans because they reduced distractions, while others, including Brown, expressed concern over safety during school shootings.

Also covered: the lawsuit filed by a Black couple in Texas after their newborn was taken away due to a home jaundice treating Black voters across the country; and sports headlines involving Shaduer Sanders and the racial disparities in how athletes are treated. The episode wrapped with a celebration of coach Dawn Stalev's new statue in South Carolina and a tribute to Essence magazine co-founder Clarence O. Smith, who died at 93. Hosts also recognized Mound Bayou, Mississippi, as the correct answer to the day's Black trivia question: the town founded by formerly enslaved people in 1887, once known as the "Jewel of the Delta." "A lot is happening across this country and around the globe," Brown said. "But what's clear is that we must stay informed, engaged, and

thanks to an outpouring of support from across the country and around the world. The NAACP has since closed the fundraiser at the family's request. "From the beginning, this campaign was rooted in a powerful truth: no child should ever be dehumanized, and love must always be louder than hate," the NAACP said. According to the organization, 100% of the funds raised—minus standard platform feeswill be placed in a trust account solely managed by the child's parents. "No member of the Rochester Branch of the NAACP has receive—or will receive—funds from these donations," the organization clarified.

The incident has drawn attention to a rising tide of hate and bigotry not only in Rochester but across the nation. Over the past year alone, the Rochester NAACP has documented a troubling number of racially motivated acts in the

area, including racist slurs painted on a bridge near Century High School, a noose and effigy used to intimidate a Black family, and swastikas and racial epithets spray-painted on the home of a local representative. Islamophobic and antisemitic acts have also increased. "This is not an isolated incident," the NAACP said. "It is part of a troubling and painful trend that continues to escalate across the country."
